ANNUAL REGULATIONS 2020





1.GENERAL

- **1.1.** The Host Country of the third International Economics Olympiad (IEO) is the Republic of Kazakhstan. The IEO will be held online.
- **1.2.** The Host Organisation of the third International Economics Olympiad is the Astana International Financial Centre's Bureau for Continuing Professional Development (AIFC BCPD).

2.DATES

- **2.1.** The IEO will take place on 7-13 September 2020.
- **2.2.** The approximate program of the IEO is as follows:
 - **7 September:** Opening Ceremony, Guest Lecture
 - 8 September: First round of the competition
 - 9 September: Second round of the competition
 - 10 September: Third round of the competition
 - 11 September: Third round of the competition
 - 12 September: Moderation
 - 13 September: Closing Ceremony
- **2.2.** All contestants, team leaders and observers are expected to have appropriate equipment and software in order to participate in the exams as well as accompanying events. Further instructions are to be provided by the Steering Committee.

3.APPLICATION AND REGISTRATION

- **3.1.** Applying as a team means that an applicant agrees with the Statute and Annual Regulations 2020, guarantees to organise contestants' selection process and support (including finding means to provide technical resources), to find and appoint team leader(s).
- **3.2.** Applications will be reviewed by the Executive Board according to the Statute.



- **3.3.** All applications should be sent to the email address of the Steering Committee: info@ecolymp.org. The Steering Committee will confirm the receipt of the application within two working days (this is not the approval of the application). There is no official form of the application letter, but it should include the name of the institution that will handle the process, its address, telephone numbers, the name and the contact details of the team coordinator. It is recommended that the letter includes an explanation of the selection process.
- **3.4.** The application deadline is 31 July 2020.
- **3.5.** The names and details of the contestants and team leaders should be provided to the Steering Committee no later than 20 August 2020 by filling in the form provided by the Steering Committee. All changes after this date are possible only upon Steering Committee approval.
- **3.6.** A team should consist of 1 to 5 contestants and 1 to 2 team leaders, one of whom is appointed team leader A.
- **3.7.** Each contestant should bring to the IEO the document confirming that he/she is eligible to participate. Scanned copy of the document is to be sent to the following email address: info@ecolymp.org.

4.FEES

- **4.1.** There are no participation fees for teams that are invited to the IEO, including up to 5 contestants and up to 2 team leaders.
- **4.2.** There are no participation fees for observers and visitors. Any person may apply to become an observer or a visitor by sending their credentials to info@ecolymp.org no later than 20 August 2020 and explaining the purposes of their intention.
