## As a data subject you have the following rights:

- 2. to request rectification of inaccurate personal data;
- 3. to request erasure of personal data (when the personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed; when you withdraw your consent and there is no other legal ground for the processing; when the personal data have been unlawfully processed; when the personal data have to be erased for compliance with a legal obligation);
- 4. to request restriction of processing (e.g., if you have confirmed its accuracy and while this is being verified by us, or if you have objected to its processing and while we are considering whether it has legitimate grounds to continue to do so);
- 5. data portability (so that you can move, copy or transfer this data easily to another data controller);
- 6. to withdraw your consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal;
